OM1 Fiber Patch Cable Family

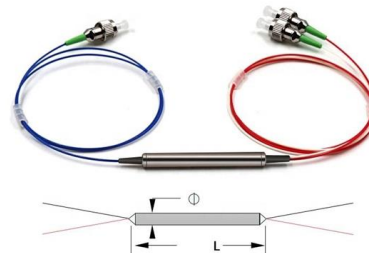
